  - a. Land Trust Plan 2015 – 2016 work session

A copy of the Land Trust Plan, CSIP Plan, and School Plan was given to the SCC. The SCC looked over the Land Trust Plan for 2014 – 2015 and discussed changes they would like to see made to the Land Trust Plan. Mary explained that if changes were to be made, the changes would need to be measurable. The school should be able to measure the effectiveness of the action plan which would result in student achievement of the goal.

Phil Handley, data manager, explained how he is able to gather and analyze school wide data such as grades and attendance. He is also able to work with teachers and departments to help them gather and analyze department specific data, such as CFA results, to allow teachers to monitor student achievement, subject understanding and progress, as well as inform teaching methods/practices and department goals.
